Des Mulcahy - A Little Bit of Family History

BORN: Cue Hospital

DATE: 15th August 1928

You will notice from my Birth Certificate that my proper Christian names are Daniel Thomas and not Des as everybody knows me.

You may be interested in a little bit of family history.

My grandmother Georgina Midlin was one of the first white ladies in Cue in the 1890's. As a teenager she came from Charters Towers Queensland with her foster father, a mine manager. Her parents and two sisters died of a typhoid fever plaque in that town.

I remember Granma telling me she cried when she first arrived in Cue as conditions were very primitive and she had only a small hessian tent to live in. Her foster father a Scotsman said "Why are you crying girl. You have a house to yourself."

Georgina married Thomas Gill. They ran a wayside inn at Gabinantha which is now a big hole in the ground as it was later a mine site. After some time they moved to Cue and were licensees of the Rosscommon and Crown Hotels.

Thomas Gill died leaving Georgina with six children. She then married Arthur (Joby) Chesson. He was a member of the large well known Chesson family who lived in Cue. Arthur (Joby) was a member of the Cue Road Board Council for several terms and a prominent supporter of the local Fire Brigade. One of his brothers Jim with his brother in law Heydon were lessees of the well known Cue 1 and Big Bell mines as well as other mines in the Cue area. Another brother Tom Chesson was a member of the state parliament. Arthur (Joby) had three more children.

Mary Gill, my mother the third in Georgina's family was born in Cue in 1906. When she was a teenager she used to play the piano for the regular Cue dances and worked in the Cue Road Board Office. She married Mick Mulcahy, manager of Milly Milly Sheep Station where I lived for the first four years of my life.

I have two sisters - Sue and Sally.

I started metal detecting in the Cue area in September 2006 and found an 80z nugget in October of that year. The following 11 winters I continued metal detecting around the Cue area staying in my van at the Cue Caravan Park. It's a great way to spend your retirement years.

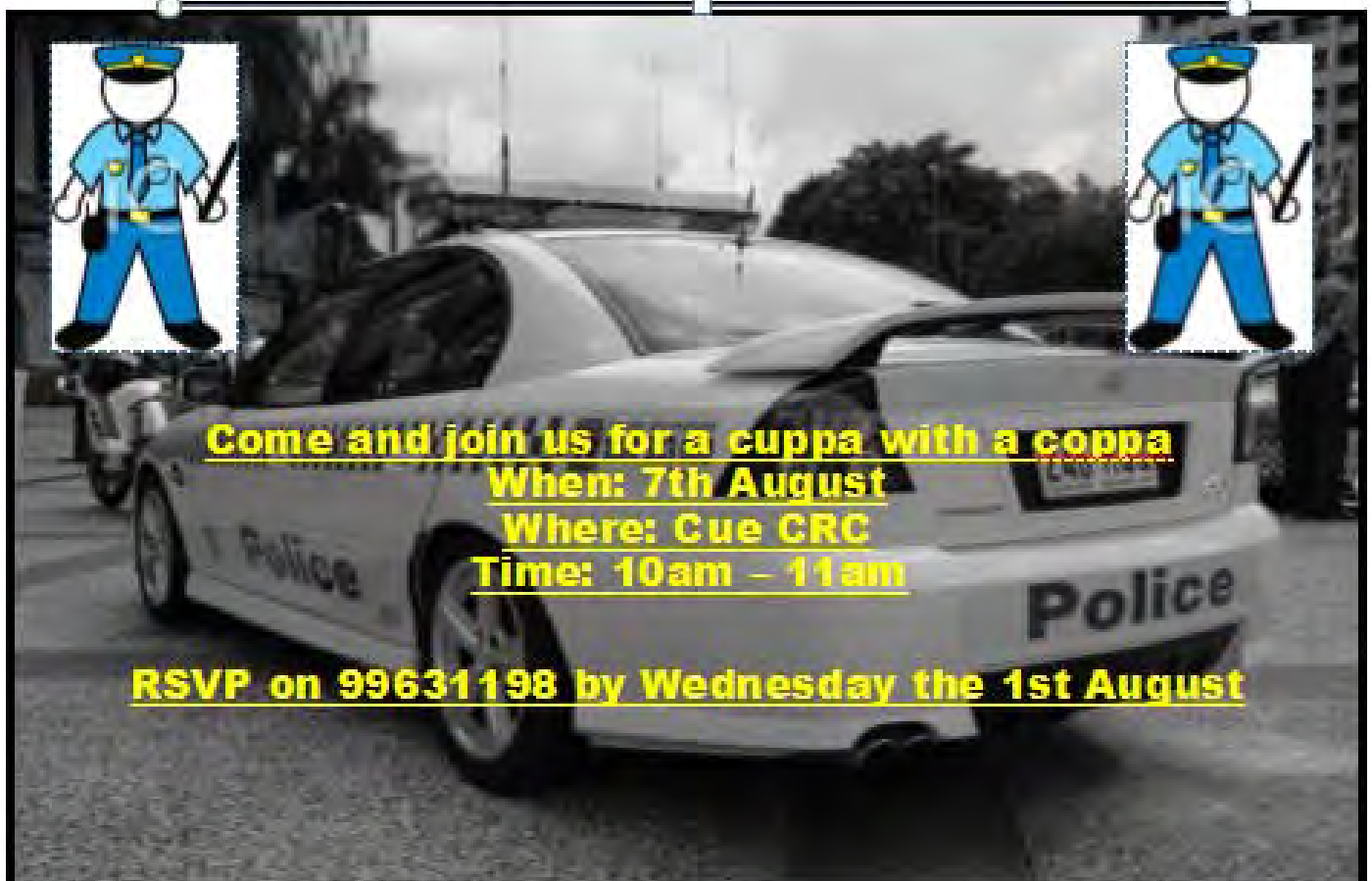

Murder at Day Dawn Part 2

James Potter's statement

James Potter, Brother of Mrs Clinton, arrived at Day Dawn by train at 10:30 on Friday January 3rd. Mrs Clinton wired to her husband to notify him that her brother was leaving and he should be expecting him, unfortunately George Bloomer received the message which Henry Smith took and burnt because he did not want Mr Clinton meeting Mr Potter. Mr Bloomer and Mr Smith welcomed Mr Potter at the station and took him to a boarding house. After 8am on Saturday morning, Mr Smith, Mr Bloomer and Mr Potter went to Mr Clintons while Mr Clinton was working. they had lunch at Mr Clintons and continued to the main street of Day Dawn by 3pm. Mr Potter wanted to see Mr Clinton when he finished work but Mr Smith urged him not to do so and remarked "if Clinton goes to shake hands with you ill knock him down."

After dinner they remained in the street until 10pm, continued through the night, they then decided to go to the Railway Station and stayed until midnight before deciding to go to Mr Clintons but Mr Clinton was not at home. Mr Potter had expressed a determination to see Mr Clinton. They all continued to stay until 1am that Sunday morning. While waiting Mr Smith said to Mr Bloomer "go over and get that dolly bar and I'll settle him." Mr Bloomer then walked over and got the dolly bar shortly before giving it to Mr Smith. About 10 minutes later Mr Clinton came along with a man named Hall, when Hall left, the three men went over to the camp, which they entered.

Mr Clinton called out "who's there?" in return Mr Bloomer responded with "its Jim." Mr Clinton replied with "whose Jim?" George Bloomer called out "Potter." Mr Clinton said, "Hold on a minute and I'll be right with you." The three of them then went into Mr Smith's room, almost immediately after Mr Clinton came to the door of the room and wanted to shake hands with Mr Potter. Potter said, "Wait a minute, I've something to say to you." Mr Clinton replied with "what about?" Mr Potter responded, "About the way you've been treating Lil" (Mr Clinton's wife and Mr Potter's sister). He said, "Where have you heard it?" Mr Potter said, "Pretty crook by what I've heard of it" he said, "where have you heard that?" Mr Potter responded, "From her, and more since I came up here" Mr Clinton claimed "it's a ----- lie. What ----- right have you got to interfere?" Mr Potter replied "as much ----- right as you have" Mr Clinton responded "well you ----- keep her" Mr Potter said "I will if you leave her" Mr Clinton then argued with Mr Smith about the telegram that he heard was delivered for him at his camp. Mr Smith denied getting the telegram. Mr Clinton confronted him and said to him "did you get a telegram?" Mr Smith replied "yes." Mr Clinton said, "It should have been for me" Mr Smith denying the claim "it should not." Clinton said, "Well there was a telegram delivered at this camp for me, sent by L.Clinton" Smith said, "it's a lie." Clinton said to Mr Smith "why didn't you let me know that Jim was coming up?" Smith responded, "You like a little surprise sometimes, don't you?" Mr Clinton answered, "it was no surprise to me, as I sent his ticket down with Lil for him to come up" Mr Clinton further said, "at any rate, you had no right to open the telegram." Mr Smith responded, "It's a ----- lie, I didn't open it." Mr Clinton said, "you stand being called a ----- liar?" Smith answered, "Yes I do, because I'm too weak to do anything else." Clinton responded, "You are not a man." Smith snapped back, "don't you dare say that." Mr Clinton laughed to himself and shortly after replied, "I will and more." Smith turned to Mr Clinton and then told him, "don't drink so much beer old man, and you wouldn't have so many rows with your wife." Mr Clinton responded, "If I drink beer I pay for it. There were never any rows between me and my wife until you came to the house.

Smith replied, "You are a mongrel for saying that." Mr Clinton beckoned him and said, "Come outside and I'll show you who the biggest mongrel is out of the two of us." Mr Smith replied, "You know I'm crook." Mr Clinton replied, "You brought it all on yourself." Smith turned to Clinton, "how's that?" he asked, "Well, since my wife has been away you've treated me with contempt." Mr Clinton replied. "I haven't, I've always treated you with respect." "No you haven't I noticed a coolness ever since. Even young George will hardly speak to me now." Clinton snapped to Smith. Smith snapped back and said. "Well that's not my fault." Mr Clinton Replied, "yes it is you've been pumping me up." Mr Smith then sat on the bed and Mr Clinton beckoned Mr Potter outside. When outside he asked, "where did you get all your information from?" Potter explained, "I got the worst of it from Smith" Clinton said, "well, look he is a ----- liar. Come out here and I will tell you the strength of it." He also said, "I brought that man here as a friend and he turned out a bigger enemy. I went out the back one night and went through the back door, I saw Smith with his hands around Lil's waist. Of course that set me going..."

"In that case, I'm satisfied there's a mistake somewhere." Said Mr Potter. Mr Clinton continued, "I know it's that swine. He's been pumping young George up and Lil too." "In what way?" replied James Potter, He said, "He was putting Lil up to say when we were rowing that she had a witness to say I knocked her down if she wanted to get a separation." "I'm so sorry I spoke now, Bill." Replied Mr Potter. "Well don't take any notice of what I told you just now. I'm very quick tempered." Mr Clinton expressed. Mr Potter turned to Mr Clinton, "alright I can see things better now." Just then, George Bloomer joined them and William Clinton said to Mr Potter "you had better stop here tonight." "No Ill finish this week over there first." Replied Mr Potter. "Well, come round here for your tucker." Mr Clinton insisted. "Yes I'll do that, I think I'll go home now." Mr Potter replied. "Alright, I'm sorry we had a bit of a row, but it's all over now." Said Mr Clinton. Mr Potter agreed and told Mr Clinton he would see him in the morning for breakfast. Before leaving Mr Potter turned to Mr Clinton and gave him some advice, "you should be on the lookout tonight." He said. "What for?" replied Mr Clinton. Mr Potter continued, "I don't think things are alright." Mr Clinton brushed it off and said, "Oh that will be alright, I'll look out for that"

Mr Potter then asked George Bloomer if he could accompany him to his room. A few moments went by then Mr Bloomer left. The next day he saw Mr Bloomer with him at his room between 8am – 8:30am on the fifth. Mr Bloomer woke Mr Potter and said the following statement. "Harry has settled Bill." When Mr Potter asked how he knew Mr Bloomer replied, "Something woke me up; it must have been the shot for as soon as I woke I smelled powder." "What did you do?" Mr Potter asked. "I could not do anything, I got such a shock," Mr Bloomer stated. "I wish to God you had not been there when the shot was fired, or id go and give the game away. What are you going to do?" Mr Potter asked. "I don't know what to do I'm frightened." Mr Bloomer stated. "I don't know what to do." Mr Potter stated. He then dressed and left the room with Mr Bloomer. Outside the room, they met Mr Smith and he said, "good morning. I've settled him." "I wish to God I never knew anything about it." Said Mr Potter. When Henry Smith asked him why and told him he was all right Mr Potter replied, "Yes but there's young George there it places him in an awkward position, being in the house when the shot was fired." "Oh, that will be alright I'll get it out of the road tonight." Mr Smith stated.

Mr Smith, Mr Potter and Mr Bloomer had breakfast and spent the morning at the railway station. After dinner they returned to the camp remaining until after 6 o'clock, Mr Smith was watching the camp while the other two were sleeping and reading. After tea, Mr Smith wanted George Bloomer to go with him and get the rifle, but he refused. "This is pretty crook, leaving it all to me. Said Mr Smith. Henry Smith got the rifle and the three took it in the motor to Cue, where Mr Smith returned it to Gribble for the owner. On returning, they again went to the railway yard. About 1 o'clock on Monday morning, Mr Potter left the other two and went to the boarding house. Mr Bloomer arrived at 7 o'clock that morning and said, "Harry is going to give himself up." "How's that?" asked Mr Potter and Mr Bloomer said "Hall came there looking for Bill last night and the candle was alright." They joined Mr Smith outside and after breakfast, they kept together except for an interval when Mr Smith went to Cue for his bicycle until evening. Mr Potter suggested that they should get Mr Smith to go to the camp and see if everything was all right and they should go to the police. As soon as Mr Smith left, they went to the police station.

George Bloomers Statement.

George Christopher Bloomer, one of the accused also made a statement. He corroborates Mr Potter closely. Mr Bloomer understood that Henry Smith did not want William Clinton to see James Potter. It would "Spoil" his plans to get Mr Clinton out of the picture and allow him to take Mr Clintons Pay for himself so he can send it to Lil and Viney, he planned to tell her that her husband had cleared out and was too heavy in debt to support her. Mr Bloomer mentioned he heard Mr Smith sitting on the bed crying and groaning about Lil and Viney. He also heard him mention getting Mr Clinton "out of the road". On the Friday (January 3rd), Mr Potter arrived at the station and George Bloomer heard Mr Smith Telling Mr Potter that he should not have come to visit because it would ruin his plans to settle Mr Clinton. On that Saturday night, Henry Smith told George Bloomer to get the dolly bar, while Mr Smith went to get another hat and overcoat James Potter said, "We will wait with him and block him." Mr Clinton came along with Hall. Henry Smith was not happy about the situation "That's a nuisance, we are spoiled again." While they were waiting for Hall to leave Mr Smith said, "I wish I had the courage, id shoot him tonight." When Hall left they all went in and after some altercation William Clinton Said to Henry Smith, "I brought you here as a friend and you have no cause to go crook on me." James Potter spoke up and said to Mr Clinton, "every right for the way you have treated my sister." Mr Clinton then said, "It's a lie you have been pumped up by Harry to turn against me." Mr Smith said, "Don't you hit me old chap, because I've not stood up to Jack Cullen for ten rounds that I don't know how to settle you."

Mr Bloomers statement was quite similar to Mr Potters, they both mentioned that Mr Smith was sat on the bed and telling them he wants to get Mr Clinton "Out of the road" words indicating he had full intention to Murder Mr William Clinton.

In Mr Bloomers statement it mentions that he was in his bed and at 4 am that morning he was awoken by a loud sound he thought could've been from the Fingall Mine or the Palmers Show, he was awoken again by Henry Smith poking I'm in the ribs and declaring he shot Mr Clinton in the back of the head, Mr Bloomer looked over at Mr Clinton and then back at Mr Smith, "you better stick with me" Mr Smith said in a threatening voice. During Sunday as Mr Potter had described they spent most of their time at the railway station. That night they took the rifle back, about midnight Mr Smith took Mr Bloomer to Mr Clinton's camp. When they got to the end of the fence Mr Smith threatened Mr Bloomer and told him to watch and not to go away. Mr Smith went to the camp, Mr Bloomer heard him running towards the shaft and pulling something as if he was trying to carry it. Fred hall went to the camp and called out "Bill, are you there?" several times. Mr Bloomer told Mr Smith on his return and he exclaimed "My God !" when Mr Bloomer declined to go inside the house, Mr Smith said, "come on no nonsense I've got him down the shaft" Mr Bloomer still refused and they went to the grandstand.

Mr Smith took the rubber off the heel of his boots and wondered if they would leave any tracks. About 6:30 they went to the railway station. Henry Smith had a cloth, wet it and wiped his trousers at the bottom; he turned to Mr Bloomer and asked him if he had any blood on his back. They went to Mr Potters room and Mr Smith said they would try to find out if Mr Hall saw anything, if he did they would go to the police station and report Mr Clinton as "missing" and they found his bed in a mess, if he had not they would go in and clean the mess.

As the detectives were likely to go to the camp Mr Smith went to see if everything was alright and while he was away James Potter and George Bloomer went to the police. On the 17th instant, at the Cue Gaol, Mr Smith said to constable Kuhlman "I will tell you my defence. Clinton rushed at me with the axe, I had to defend myself and grabbed the rifle, there was a struggle in the camp, the rifle went off and shot Clinton." Mr Smith also asked "what do you think of it?" Kuhlman, in court stated that on the 21st instant Mr Smith said, referring to Mr Potter and Mr Bloomer, "they're witnesses already. One of them was in the room at the time I shot Clinton, and saw it all." Mr Smith denied saying this and added, "I think I said to you Bloomer was in my room."

Henry Smith Gives Evidence

Smith, the accused, was sworn, but after being cautioned said he did not want to give evidence. In answer to the coroner, he said he had resided at Clinton's place for about four weeks. He made no statement to the police regarding the death of Clinton. It was alleged that a statement had been made, but it was not put in as it was unsigned, He denied that he had said Mr Bloomer was in the room.

He said that he, as in his (Smith's) room. Potter was not in the house at all. 'No one saw it, or knew what had taken place.

The Coroner: what was the purpose of obtaining the bar of iron on Saturday night?

Smith: I do not remember anything about it.

The Coroner: "Where -was the gun kept?

Smith: Outside the house on the veranda, outside my room. The veranda was practically a closed-in room. I cannot remember where the gun was the night Clinton was shot.

The Coroner: At what time was Clinton shot?

Smith: I could not say. About a quarter to 5 o'clock on Sunday morning, I think. I had gone out for a drink of water. That was before the shooting happened.

Oh Friday the Coroner (Warden Troy) /reviewed the evidence. He pointed out that Mr Smith admitted shooting Mr Clinton, but said it was owing to Clinton rushing at him with a hammer; but Smith had expressed his determination on several occasions to "settle" Clinton, and had actually waited with an iron bar to attack him. There was no evidence of a row immediately prior to the shooting, and the medical testimony went to show that Clinton was shot while lying down asleep. As far as he could see, there was no evidence to make Potter an accessory before the fact. As regarded Mr Bloomer, he was more closely associated with Mr Smith, and had rendered some assistance; afterwards in the way of cleaning up. He would leave them to say 'whether there was sufficient evidence to warrant a verdict of wilful murder, murder, or manslaughter against Mr Potter and Mr Bloomer. As regards to Mr Smith, it seemed to him that the evidence was extremely strong against him, and it seemed to him that the whole evidence pointed to Mr Smith having wilfully shot Mr Clinton. The jury returned a verdict of wilful murder against Smith.

Henry Smith was sentenced to death, James Potter gave no more statements after the verdict against Mr Smith. George Bloomer went on to have three sons, he fostered out one of the sons and the other two he gave to an orphanage. Years later Malcom Bloomer (the fostered son of George Bloomer) had a daughter. Fortunately, she is still around today and making many appearances. Lisa McCune had no idea her biological grandfather was part of great history and a mystery murder.

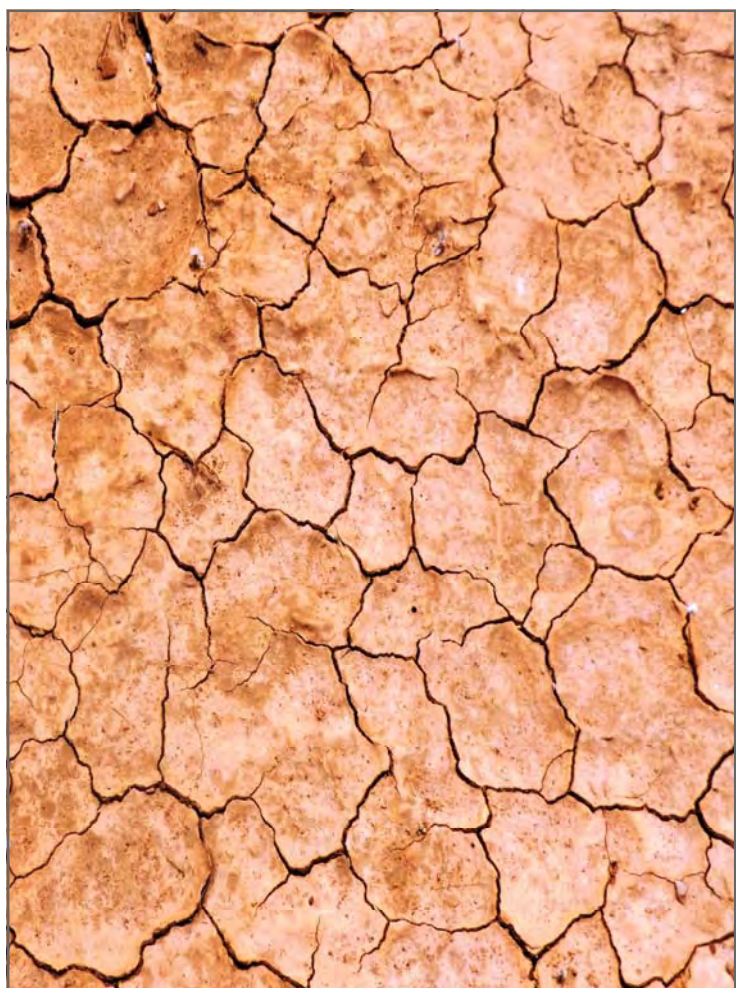

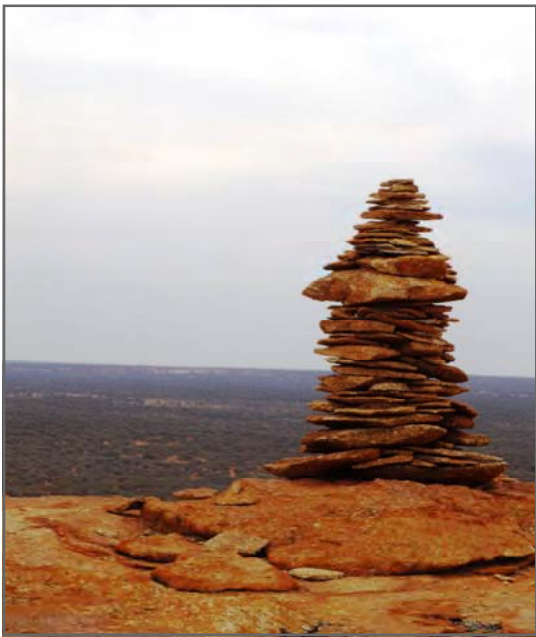

The Gold rush at Cue had been heard of in mining towns in the Eastern States of Australia and soon miners began to flock to the west. Among these was a man named James Chesson. He was 25 years old in 1893. He specialised in the Sheffield Handicap, a foot race over 130 yards. He began to save his money with the idea of travelling to Cue. Jim Chesson slowly made his mark at these meetings throughout the district and became well known to the followers of the sport.

With nearly sufficient money in the bank to safely undertake a trip to Cue, he decided on a killing at one of the big athletic meetings. He trained long and hard for the eagerly awaited day, and when he considered that he had been given a reasonable mark from which to run he arranged for his mates to back him to win.

The day came around and James was fighting fit and extremely confident of running well. He won his heat in comfortable time, was successful in the semi finals, having run well within himself, when the final came he stood on the mark relaxed and confident, dreaming of the money that would come from a win, and the plans that he would make for the exciting trip to the new gold fields of Western Australia. The starter called them to the line and before they knew it they were off and running side by side, shoulder by shoulder. Jim was in third place and comfortable with his position in the race, he was confident he had the men in front of him well covered and was not afraid of the runners behind him. He increased the pressure and with twenty yards to go was level with the two other runners in front of him. Running well within himself he was a stride clear as he crossed the line to the cheers of the crowd. His dream of fortune on the Western Australian Goldfield was now within his grasp. Sadly the judges declared he had placed second and was not declared the winner of the race.

He then pursued his athletic career to Cue. At Geraldton he decided to spend a few days in making enquiries regarding his trip to Cue, it was undecided as to whether he would travel by coach from Mullewa to Cue or whether he would walk the 200 miles to save his rapidly dwindling bankroll. He caught the train from Geraldton to Mullewa and continued to make the rest of his journey on foot. He anticipated it would take him 10 days to make it to Cue. About 9 days out of Mullewa he passed a teamster his wagon back to Mullewa, he mentioned that the races in Cue would be held in 2 days.

Jim was excited even though he had 3.5 miles to walk he decided to get to Cue in time to nominate for the main race. The next day after walking about a mile and half he noticed a movement under a tree not thinking anything of it the first time he noticed it as a person, an old prospector perishing of thirst. Without food or water. Jim stopped to assist the man and saved his life by giving the man his water bag. He promised to help the prospector and continued his walk to Cue in hope to find someone to assist him. He was now faced with a 9 mile walk without water and lost valuable time with the sick man.

After reaching Cue and making arrangements for the sick man to be cared for he found that he was too late for the race, he was a betting man and prepared to take a chance at anything involving foot running. He asked if he could have a chance to run and to earn a winners title even though a winner and champion of Cue and Day Dawn had already had been declared. It was agreed to and they allowed him to race. They approached the line together and before they knew it they were off and running. Side to side, shoulder to shoulder until finally...James Chesson was declared the winner. He not only walked over 200 miles in 10 days but was now the new champion of Cue.
